Nakhonsithammarat Primary Educational Area Office 1 focus on administration with integrity and transparency policy of the Prime Minister Gen. Prayut Chan-o-cha on September 12, 2014 on the promotion of the national administration with good governance and anti-corruption and misconduct in the public sector according to Code of Ethics for Civil Servants B.E.2552, Regulatory compliance manual in civil service code of conduct of Office of the Basic Education Commission B.E.2552, Code of ethics for civil servants in Office of the Basic Education Commission, Announcement of Office of the Basic Education Commission on June 22, 2011 in policy concerned transparency and accountability as a guide to assess the integrity and transparency on the operations of government agencies (Integrity and Transparency Assessment: ITA) of the Office of the National Anti-Corruption Commission (NACC) and Office of Public Sector Anti-Corruption Commission (PACC)

- 1. Perform all the steps according to laws, rules and regulations strictly and promote all personnel to work under the laws, rules and regulations.
- 2. Cultivate and create awareness, values in anti-corruption, can distinguish between personal benefits and public benefit in order to cultivate morality and consciousness in preventing corruption in the office, with strong and effective internal counterbalance will make personnel aware of the perils effects of corruption to government office and the country to create a culture of anti–corruption.
- 3. Do not accept and tolerate corrupt behaviors that causing social sanctions which may make personnel in Nakhonsithammarat Primary Educational Area Office 1 shame or fear to commit corrupt behaviors.
- 4. Instill consciousness to students in the school under Nakhonsithammarat Primary Educational Area Office 1 to aware of the peril effects and to anti-corruption.
  - 5. Operational Guidelines and Collaborative Activities
- 5.1 Coordinate and cooperate with the national strategy B.E.2541-2580 Balancing and developing government management systems
- 5.2 All units and personnel collaborate and join network to prevent and suppress corruption in Nakhonsithammarat Primary Educational Area Office 1 with central unit and school
- 5.3 Conduct research, collect knowledge for prevention and suppression of corruption

5.4 Co-organized about the knowledge of the national strategy B.E.2541-2580 Balancing and developing government management systems, especially guidelines for the promotion of morality to the office administrators, school administrators and educational personnel in Nakhonsithammarat Primary Educational Area Office 1 which concerned with education management of the Office of the Basic Education Commission. Create knowledge, understanding and participation in dissemination and campaign for youth, parents and the general public to make them take part in the anti-corruption activities and engage in network of anti-corruption.

5.5 Co-organized about the knowledge of the surveillance and monitoring for anti-corruption for educational personnel in Nakhonsithammarat Primary Educational Area Office 1, namely the deputy directors of Nakhonsithammarat Primary Educational Area Office 1, department directors, school directors and educational personnel concerned with education management in all level. Create knowledge, understanding and participation in dissemination and campaign for youth, parents and the general public to make them take part in the anti-corruption activities and engage in network of anti-corruption.

5.6 Construct the measurement indexes of moral and transparency for agencies under Office of the Basic Education Commission and implement the guidelines

5.7 Construct the communication channels, publish and promote to support the implementation of cooperation networks in the prevention and suppression of corruption

5.8 Provide consultation and guidelines recommendation including monitoring and evaluation the implementation of such cooperation operations.

5.9 Implement any joint action in the prevention and suppression of corruption in all ways at full capacity.
